and Share alike, fifthly, I give Devise
and bequeath unto Antia the wife of
Daniel van Winkle my large Cupboard
Bed bolster and Pillows Curtains also my
Diaper Table Cloth and bed-head also my
large Bible and all my kitchen furniture
such as Pots kettles Subs Trammel Pans
and Shovels to her the said Antia her heirs
and Assigns forever, sixthly, I give devise
and bequeath unto Antia the wife of Corne-
lius Buskirk my large looking Glass,
seventhly, I give Devise and bequeath unto
Jannetie the wife of Garck 2 van Riper
of Acquahonk my large Chest, eighthly, I give
devise and bequeath unto Rachel the daughter
of Daniel van Winkle my Executor my Sil-
ver Shoe buckles, ninthly, All the Residue
and Remainder of my moveable Estate
I give Devise & bequeath unto the Daugh-
ters of my said Two Brothers Levine & John
to be Divided amongst them Share & Share
alike lastly I do nominate constitute &

Appoint my trusty friend Daniel Ben
winke with whom I now reside sole ex-
ecutor of this my last will and testament

wills by me heretofore made & declaring this
only to be my last will & Testament, In
