Facilities are provided in the Pakim Pond recreation area for family picnics. At Deep Hollow Pond both families and groups can be accommodated upon payment of a nominal table for.

Fincin first are permitted, but must be confined to the metal stores and fireplaces provided, or to stores throught by the picnicker subject to approval by a forest officer.

Charcoal may be purchased from the forest officer.

Parking of vehicles should be done at spaces provided. Vehicles may not be parked along roads where use of the full road would be blocked, or off the road where trees or plants would be damaged.
