2014 Floriculture Crop Highlights for the Northeastern Region

Value of All Production: The 2014 wholesale value of floriculture crops in the 4 program states of the Northeastern Region (MD, NJ, NY, and PA) is down 6.6 percent from the 2013 valuation, according to King Whetstone, Director of the USDA's National Agricultural Statistics Service (NASS), Northeastern Regional Field Office. The total crop value at wholesale for the 4 program States in the Northeastern Region, for all growers with \$10,000 or more in sales, is estimated at \$598 million for 2014, compared with \$641 million for 2013. New Jersey continues to be the leading State in the region, with crops valued at \$196 million. New York, the next largest producer, is down from the prior year to \$155 million in wholesale value.

Number of Producers: The number of producers with operations having \$10,000 or more in sales for 2014, at 1,412, is down 23 percent in the 4 States, compared with the 2013 count of 1,821.

Area Used for Production: In the Northeastern Region 4-State program, total covered area for floriculture crop production was 74.1 million square feet, for operations with \$10,000 or more in sales. This is down 7.5 percent from the 2013 area of 80.1 million square feet.

Total Wholesale Value: The total wholesale value of floriculture crops sold by operations with \$100,000 or more of sales in the Northeastern Region's 4-State program is \$567 million for 2014, down 3.9 percent from the 2013 total. These operations account for 95 percent of the total value of \$598 million in floriculture crops, but comprise only 43 percent of all producers.

Number of Producers: The number of producers with sales of \$100,000 or more totaled 606 for 2014, down slightly from the 618 producers counted in 2013.

About the Survey: The Commercial Floriculture Survey is conducted annually by USDA's National Agricultural Statistics Service (NASS) in 15 states. It is a "census" of all known operations with more than \$10,000 in floriculture sales. For operations with more than \$100,000 in sales, detailed data is collected about specific varieties.

All values in the following tables are wholesale equivalent value of sales; they were derived by multiplying the average wholesale price by the total quantity sold. Data summarized in the tables showing grower numbers and growing area represent all growers having sales of \$10,000 or more.

The results of the survey are available to the public. Associations use these statistics when working with policy makers at the state and national levels. University extension specialists justify research grants and other activities with statistics that describe the size and importance of the industry in each state. Banks and other lending institutions often use the data when evaluating loan applications. Individual producer data is kept strictly confidential and used only in combination with other reports to prepare state and national statistics. Individual information is exempted from disclosure under the Freedom of Information Act.

The Northeast Region was represented in Maryland, New Jersey, New York and Pennsylvania for the purposes of this survey. Fifteen states were included in the national release.

Survey Definitions

Floriculture Crop: Any item considered in the categories of annual bedding and garden plants, potted herbaceous perennials, potted flowering plants for indoor and patio use, foliage plants for indoor or patio use, cut flowers, cut cultivated greens, and propagative floriculture materials.

Commercial Producer: Any operation which produces any commodity listed above and whose gross sales total \$10,000 or more during the calendar year.

Area Used for Production: Greenhouse, other covered space, and outdoor area used for the production of floriculture crops. Walkways and aisles are included. Multiple uses of the same area are counted only once, without counting crop turns. Covered area includes glass, rigid plastic and film plastic greenhouses, and shade houses.

Quantity Sold: Represents both retail and wholesale sales in the calendar year shown. Flowers, plants, or materials purchased from others for immediate re-sale are excluded.

Expanded Wholesale Value: Value of all crops grown, at wholesale, for growers with sales of floriculture crops of \$10,000 or more. This figure is the sum of two parts. The first is the wholesale value of sales as reported by operations with \$100,000 or more in sales. The second part is an estimated value for operations with sales between \$10,000 and \$99,999. The value is derived by multiplying the number of producers in each range of sales by the mid-point of the range.

Value of All Sales at Wholesale: Equivalent wholesale value of all sales. It is derived by multiplying the average wholesale price by the total quantity sold (both retail and wholesale). Wholesale prices are on a gross basis before deductions for sales commissions, transportation charges, or other similar deductions.
