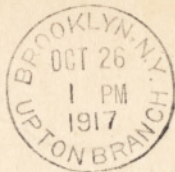
I have just received word from my brother and in his absence, I am taking the privilege of answering your letter of the 12th. His address is % Camp Quartermaster, Camp Upton.

Dear Sir:

No doubt you are wondering why you have not yet received a copy of our promised letter to the War Department concerning your brother Mr. Elmer F. Walker. After consultation it was decided that such a letter as you proposed could not in any way aid your brother towards promotion and might, on the other hand, do some harm. The War Department does not favor outside interference.

It may be possible that later we shall have an opportunity to recommend your brother for the next Officers' Training Camp. If such is the case, you may be sure that we shall be pleased to do whatever possible, but in the present instance, we believe that any action whatever on our part would not be the best thing for him.

If you are still convinced that we should take up the matter, I shall, upon advice from you, send a general recommendation to the commanding officer at Camp Upton.
